With the maturity of our community comes a few maintenance items that we will be looking at over the next 3-4 months that include the following: -Reviewing Spillways to be repaired and taking bids

-Refresh of entrances that includes possible tree replacement and have agreed to go with fuller flowers by same company that works with Cooper Estates

-Clubhouse Roof Replacement due to storm damage is moving forward. Due to current shingle having manufacturing issues we are moving forward with another similar quality shingle
